Mission Focused

- Community Response/Recognition** – Awards one-time grants each year to area nonprofit organizations addressing unmet community needs. Every other year recognizes an individual and/or organization whose efforts promote the mission of the VIA.
- Home Life** – Enriches the lives of the residents at Pine Run and Lakeview senior facilities.
- Teen Educational Scholarships** – Awards scholarships to outstanding high school seniors pursuing healthcare careers and to sophomores for leadership training.
- Veterans** – Supports the health and welfare of veterans in our community.
- Welfare*** - Supports those in need through individual and organizational donations.
- Women's Scholarship*** - Provides educational support for women pursuing training to improve their life circumstance.

Operational

- 1895 Society*** - Recognizes monetary donations to the VIA.
- Designer House & Gardens** – VIA’s largest fundraiser to support the mission and Doylestown Hospital.
- Finance*** – Manages VIA finances, budgets, IRS 990 submission, and financial policies.
- Fundraising** – Operates events and sales to generate funds to fulfill the VIA mission.
- Governance*** - Responsible for reviewing bylaws and policies, Board development, and membership management.
- Information and Technology** – Oversees the data and systems needed for operations.
- James-Lorah Memorial Home** – Manages the upkeep of the VIA’s headquarters, historic home and auditorium use.
- Marketing** – Promotes the VIA to the hospital staff, patients and community to help build awareness of the VIA.
- Membership** – Welcomes new and prospective members to the VIA; encourages participation in the VIA.
- Preservation of Records** – Ensures VIA records are maintained for posterity.
- Strategic Planning*** - Develops and maintains VIA’s Vision, Mission and Values.

- Floral Arts** – Creates floral displays for VIA events and holiday décor.
- Hospitality** – Provides food and beverages for VIA meetings.
- Literature Workshop** – Discusses books read by the group and/or participate in circulating current best sellers.
- Program** – Identifies and manages informative, educational, and entertaining programs for VIA Membership Meetings.
- Social** – Creates and manages activities and events for member socialization and enjoyment.
